The major contributors to the increase in the Total Comprehensive Income for the quarter are :

- ☆ Improved performance of franchised distribution businesses primarily driven by reduction in T & D losses;
- 1 Higher profits from Renewables business due to increased capacity of wind power projects;
- ☆ Favourable movement in deferred tax charge arising from a change in computation method adopted in the previous year, which resulted in additional charge in the comparative quarter.
- Recognition of regulatory gap balance on accrual basis effective from 1st April, 2018 (due to change in accounting policy in compliance with new accounting standard Ind AS 115 Revenue from contract with customers);
- Increase in finance and depreciation costs, reflecting additional capex in distribution and renewable projects.

Generation:
