Hon'ble GERC, under the said orders, inter-alia, approved recovery of past period gaps (net of revenue surplus of FY 2016-17) of Rs. 470.50 Crore by way of "Regulatory Charge" at 45 paise/unit. Recovery of "Regulatory Charge" has to be stopped once the said gaps are recovered in full during the year.

While allowing such "Regulatory Charge", Hon'ble GERC has endeavoured to reduce the electricity bill of consumers by 18 paise/unit by capping the recovery of FPPPA during FY 2016-17 at Rs. 1.35/unit compared to the present FPPPA of Rs. 1.98/unit, in view of the recent trend of reduction in fuel price.



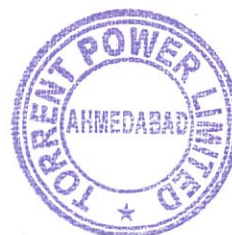

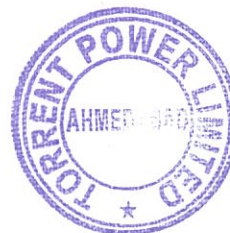
