- Torrent Power Limited (hereinafter referred to as "TPL-D"), has filed its petition vide Case No. 2323/2024 for (i) Truing up of FY 2022-23, (ii) Determination of ARR for FY 2024-25; and (iii) Determination of tariff for FY 2024-25 for its Distribution business of Ahmedabad/ Gandhinagar Supply Area,
- The truing up for FY 2022-23 is proposed as per the actuals of FY 2022-23 in accordance with GERC (Multi Year Tariff) Regulations, 2016.
- The Revenue Gap/ (Surplus) of FY 2024-25 for Ahmedabad/ Gandhinagar Supply Area is arrived at considering the estimated ARR for FY 2024-25 in accordance with the GERC (Multi Year Tariff) Regulations, 2016 and estimated revenue based on existing tariff and revised base FPPPA.
- 4. The cumulative gap for FY 2024-25 is arising mainly on account of past years' under-recovery. Therefore, TPL-D is not proposing any increase in tariff and is proposing to recover the cumulative gap by way of Regulatory Charge of Rs 0.44 per unit over the period of three years starting from 1st April 2024 from all consumers.
- FPPPA charges shall be recovered in accordance with the approval of the Hon'ble GERC.
- TPL-D has also proposed to continue optional "Green Tariff" with additional tariff of Rs. 1.50 per unit for FY 2024-25.
- TPL-D has proposed to implement the tariff with above changes with effect from 1st April, 2024.
- Open Access Charges: TPL-D has proposed to determine the wheeling charges and cross-subsidy surcharge applicable to Open Access consumers.
