**PUBLIC NOTICE**

1. Torrent Power Limited (hereinafter referred to as "TPL"), has filed its petition vide Case No. 1697/2018 for Truing up of FY 2016-17 and Determination of tariff for FY 2018-19 for its Distribution business of Surat Supply Area.
2. The truing up for FY 2016-17 is proposed as per the actuals of FY 2016-17 in accordance with GERC (Multi Year Tariff) Regulations, 2016. The Revenue Gap/ (Surplus) of FY 2018-19 for Surat Supply Area is arrived at considering the approved ARR for FY 2018-19 in accordance with the GERC (Multi Year Tariff) Regulations, 2016 and estimated revenue at existing tariff on approved sales for FY 2018-19.
3. The cumulative gap including carrying cost for tariff determination of FY 2018-19 works out to Rs. 67.79 Crores. This entire gap pertains to under-recoveries of past years. Hence, **TPL is not seeking any tariff increase towards future costs** and is proposing to recover this cumulative gap of past under-recoveries by way of **Regulatory Charge @ Rs. 0.20 per unit during FY 2018-19.**
4. **Open Access Charges:** TPL-D has proposed to determine the wheeling charges and cross-subsidy surcharge applicable to Open Access consumers.
5. **FPPPA:** Base FPPPA remains unchanged at Rs. 1.23 per unit
