PUBLIC NOTICE

1. Torrent Power Limited (hereinafter referred to as "TPL-D"), has filed its petition vide Case No. 2033/2021 for (i) Truing up of FY 2020-21, (ii) Determination of ARR for FY 2022-23; and (iii) Determination of tariff for FY 2022-23 for its Distribution business of Ahmedabad / Gandhinagar Supply Area.
2. The truing up for FY 2020-21 is proposed as per the actuals of FY 2020-21 in accordance with GERC (Multi Year Tariff) Regulations, 2016.
3. The Revenue Gap/ (Surplus) of FY 2022-23 for Ahmedabad / Gandhinagar Supply Area is arrived at considering the estimated ARR for FY 2022-23 in accordance with the GERC (Multi Year Tariff) Regulations, 2016 and estimated revenue based on existing tariff and revised base FPPPA as per proposed power purchase cost on estimated sales for FY 2022-23.
4. The cumulative gap for FY 2022-23 is arising mainly on account of past years' under-recovery. Therefore, TPL-D is not proposing any increase in tariff and is proposing to recover the cumulative gap by way of Regulatory Charge of Rs 0.22 per unit over a period of two years with necessary adjustment of cost due to deferment of recovery.
5. It is proposed to recover the gap & carrying cost for matters pending with Hon'ble GERC /APTEL by way of Regulatory Charge.
6. FPPPA charges shall be recovered in accordance with the approval of the Hon'ble GERC.
7. TPL-D has also proposed to introduce optional "Green Tariff" with additional tariff of Rs. 0.50 per unit for FY 2022-23.
8. TPL-D has proposed to implement the tariff with above changes with effect from 1st April, 2022.
9. Open Access Charges: TPL-D has proposed to determine the wheeling charges and cross-subsidy surcharge applicable to Open Access consumers.
