#### **Explanatory Notes:**

#### A. Encumbrance on Shares held by Promoter

Torrent Pvt. Ltd. ("Promoter"), as promoter of Torrent Power Ltd. ("TPL") has executed "Non-Disposal Undertakings" ("NDUs") in respect of 12,49,60,364 equity shares held by it in TPL, for the benefit of specified lenders, for loans granted by them to TPL.

Also, Promoter of TPL has accepted covenant in respect of 12,49,60,364 equity shares held by it in TPL, for the benefit of specified debentureholders.

The primary obligation undertaken by the Promoter in such NDUs / covenants is to hold and continue to hold atleast 26% of equity share capital of TPL during the period such loans / debentures are outstanding. The NDUs / covenants do not create pledge or similar security charge on equity shares which are subject matter of the NDUs / covenants.

The sole purpose of executing the NDUs / accepting covenants is to provide comfort to such lenders / debentureholders that the Promoter will continue to hold atleast 26% equity shares in TPL during the period of such loans / debentures.

Promoter has executed multiple NDUs / accepted various covenants in respect of several loans / debentures taken by TPL; however cumulatively these NDUs / covenants obliges the Promoter for 26% of the equity shares of TPL.

#### B. Details of Locked-in of Shares:

Pursuant to SEBI circular No SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated 06.11.2018, Company had approved the request of transfer of shares received from Pinky Abhishek Doshi (Transferee). According to the requirements of the said circular, our Registrar & Transfer Agent, M/s Link Intime India Private Limited had Locked-in the said securities for a period of 6 (Six) months from the date of registration of transfer i.e. 23.09.2019 and the said shares need not be transferred / demated during the lock-in period.

We have intimated the aforesaid compliance to the stock exchanges vide our letter dated 20.08.2019 and 03.10.2019. Therefore, we have shown lock-in shares of Transferee in public category.

### C. Significant Beneficial Owners (SBO):

The Companies (Significant Beneficial Owners) Rules, 2018 is not applicable to the extent of shareholding of the Holding Company, it being the Core Investment Company and regulated by Reserve Bank of India.
