Pursuant to Regulation 30 of the Listing Regulations, we would like to inform you that the Company has received the demand order dated March 27, 2026 at 6.27 pm from the Office of the Additional Commissioner, Agra, Lucknow, CBIC, State : Uttar Pradesh in reference to order dated March 25, 2026 of the Office of The Principal Commissioner, CGST & Excise, Agra demanding ₹ 94.71 Crs of CGST & SGST for the period from April 2019 to September 2024 under the provision of Section 74 & 74A of CGST Act 2017 read with Section 74 & 74A of UPGST Act 2017 read with Section 20 of IGST of 2017 in relation to GST on rent on immovable properties and on incidental and ancillary services. The department has also imposed a penalty of similar amount of ₹ 94.71 Crs under Section 74, 74A, 122 of CGST Act, 2017 read with Section 74 & 74A of the UPGST Act read with Section 20 of IGST Act, 2017.
